RE: NOTIFICATION TO CEASE AND DESIST & TEMPORARY SUSPENSION OF USAGE OF SASG RIGHTS AND PRIVILEGES

On April 2, 6, 7, 9, 10, 11, 17, 2024, we sent you notification, via emails and letters, that SASG is still upholding our request for you, and your associates, to provide us with official banking and financial reports to us by April 19, 2024, and to Cease and Desist usage of SASG rights and privileges, under Temporary Suspension, until SASG receives requested reports. Non-compliance will result in Permanent Suspension to use SASG rights and privileges. You are hereby advised to *Cease and Desist* avoidance which is a crime.

You are hereby reminded to be law abiding and corporate citizens, to report our banking and financials records, and to provide us with printouts from NSB Bank Server documenting any and all transactions, successful or not, or be cancelled.

Our notifications are applicable to you, your associates at Niisitapi Sovereign Bank (NSB), Central Bank of Niisitapi, Niisitapi Development Bank, and NSB Board of Directors (BOD) who are from Smart Portfolio Group Proprietary Limited (SPG) Directors Francis Seow, Art Sao, Herald Kereama, of Australia and New Zealand; and Director Art Sao of [REDACTED]

SASG NAME INFRINGEMENT & HISTORICAL TRSPASSING OF SASG ADDRESS RIGHTS

Our SASG name was founded 100%,by Byron Bruised Head, Eugene Carlos Fox, and others, not including Mr. Shade. SASG filed its name with International Court of Justice. SASG cannot be reproduced, or used, by anyone without SASG consultation and authorization.

As for Aapaitapitapii, nothing has failed. Our legal Sovereign rights are still being addressed and brought forth in the Courts. We don't need to take direction from opportunist people, or "Wannabe" persons, using our true sovereignty and identify for their own benefit.

Any Agreements, with or without SASG name, without our written consent, are impersonating SASG by using our address, unlawfully, to commit mail fraud, forgery, wire fraud, bank fraud, identify theft, all serious crimes under Criminal Code of Canada (CCC). Our ancestral historic address is: Blackfoot Territory Treaty 7, Elders Centre Building 4, P.O. Box 73, Standoff, Alberta Canada T0L 1Y0.

NIISITAPI SOVEREIGN BANK SASG BOARD OF DIRECTORS (BOD) MEETING APRIL 10, 2024

In response to your comment about "divide and conquer", it appears this was intended by you and other NSB Board of Directors (BOD) Art Sao and Harold Kereama when you decided to pass a motion to remove Byron and Eugene from NSB BOD on April 10, 2024, at 3:12 p.m., as posted in your email/agenda for BOD meeting at 5 p.m. Your Agenda, indicates you, and other NSB BOD, already called for a motion, voted and passed, to remove Byron Bruised Head and Eugene Fox from NSB BOD before 5 p.m. meeting convened.

Mr. Bruised Head and Mr. Fox were not present at meeting and proceedings, thereof, were not valid. The only people authorized to participate in BOD meeting are original NSB SASG BOD: Bruised Head, Eugene Carlos Fox, Chris Shade, Art Sao, Harold Kereama. We had no consultation or knowledge about appointment to BOD for Alan Noor from SPG.

Agenda stated:

3. "I all (call) a Vote for the removal of Mr. Eugene Fox and Mr. Bryron Bruised Head as Directors and Board Members of Niisitapi Sovereign Bank of SASG, for allegations purported towards Members of the board and intent of dissemination of falsehoods bring the Bank into disrepute."

5. Chairman's Address: "Per the majority votes, the Niisitapi Sovereign Bank of NSB Board were satisfied that you are unfit to uphold the functions of a Member of this Bank, and that notice be given that you have been removed office, this decision to take effect immediately."

SASG Sovereign chiefs, SAASG Founders, SASG BOD, as majority 51% creators and owners of NSB SASG, governs itself. Our ownership is not changed or extinguished by your BOD vote, therefore, SASG hereby:

1. Effectively immediately, with Legal Reasons to do so, your position as SASG NSB Chairman is, hereby, revoked. your position as SASG NSB Chairman, and replaced you with Byron Bruised Head, now named SASG Chairman.
2. Disregards ,and does not, accept your decision to remove Mr. Bruised Head and Mr. Fox from BOD.
3. Recognizes you and other BOD, attempted to alter balance of through "hostile takeover" of NSB SASG and BOD.
4. Recognizes your vote for removal automatically created a Conflict of Interest, breach of SASG Trust, and alliance with BOD from SPG.
5. Acknowledges you have not enforced your fiduciary responsibility to SASG, especially, after numerous times when SASG reported to you suspected b mail fraud, forgery, wire fraud, bank fraud, identify theft, Internet fraud..
6. Recognizes NSB Chairman allowed historical trespassing of SASG ancestral sovereign address by NSB fiduciary derivatives,

Herein, we, hereby, resolve as follows:

1. Moved, seconded and carried. To outright reject the attempted Coup d'Etat by Mr. Chris Shade and SASG's invited 49%, including non invited members, thereof. The decisions of the 49% empowered by NSB SASG Chairman Chris Shade, are hereby revoked by lack of proper consultation, approval, or warning, for 51% Sovereign Chiefs ownership.
2. Moved, seconded and carried. The BOD meeting of Mr. Shade and the SPG 49%, designed as informed, to take away authority from Funding Sovereign Chiefs and Sovereign Address owned and used by NSB and its banking derivatives thereof,, is hereby rendered null and void, due to:
 - a) NSB Chairman only represents in Trust the SASG Sovereign Chiefs 51%.
 - b) SASG Sovereign Chiefs were not allowed to attend mockery of BOD democracy.
 - c)) Decisions were taken and communicated, prior to the scheduled BOD.
 - d) Lack of quorum of 51%, as done, makes it illegal, non-binding to the 51%.
 - e) No Transparency in Reporting Financials, key to halt all privileges.

Because of, and not limited to the above, non-reporting by April 19, 2024, shall render null and void, by legally binding reasons of record, all positions of Trust empowered by SASG for NSB SASG, and all of its derivatives, [REDACTED]

As of April 19, 2024, the communicated suspensions of privileges, becomes permanent, and all rights are recovered to SASG and NSB SASG, and all its derivatives thereof. All decisions taken by the trespassing ex Chairman Chris Shade, without written request for consent, thus, becomes null and void, by the sole Ministry of the Law. Non-consultation takeover is considered mutiny in Maritime Law.

You told Byron and Eugene you were appointed as NSB SASG Chairman by Art Sao and Harold Kereama of (SPG. Effective immediately, we, hereby, release you from your position as Chairman. Now you may continue your work with SPG.

SASG no longer authorizes you to represent SASG in any form of banking, financial, business, or with any and all other matters, with Niisitapi Sovereign Bank SASG, Central Bank of Niisitapi, Niisitapi Development Bank, [REDACTED] or with any and all of their derivatives, world-wide..
