**RE: SASG REQUEST FOR FORMAL RECOGNITION OF OUR SOVEREIGN BLACKFOOT RIGHTS, RENEWED NOTIFICATION TO CEASE AND DESIST, PERMANENT SUSPENSION OF SASG RIGHTS AND PRIVILEGES**

Due to deceptive and fraudulent banking practices, this letter serves SASG REQUEST FOR FORMAL RECOGNITION OF OUR SOVEREIGN BLACKFOOT RIGHTS, RENEWED NOTIFICATION TO CEASE AND DESIST, AND PERMANENT SUSPENSION OF SASG RIGHTS AND PRIVILEGES, associated with SASG, Niisitapi Sovereign Bank SASG, Central Bank of Niisitapi, Niisitapi Development Bank, any/ all derivatives, including Niisitapi Sovereign Bank, newly formed by Chris Shade, Art Sao, Julian T. Ross.

SASG does not authorize any of you to:

- (1) Use our Sovereign Blackfoot names, includes: Sovereign© Aapaitsitapii© Siksikaitsitapiskahkoo© Government©, Niisitapi Sovereign Bank SASG, Central Bank of Niisitapi, Niisitapi Development Bank, and any and all derivatives, thereof, or affiliate and misrepresent yourselves under the guise, exploitation, and proliferation, of our Sovereign Blackfoot identity, in any financial, business, matters.
- (2) Use our Sovereign NSB KTT Contract/Server(s), developed for Niisitapi Sovereign Bank SASG, specifically in 2021, by Mr. Eleazor Diaz and Hipercapital Finance Offshore Bank Panama SA.

Effective immediately, for audit purposes, we (1) request all of you to provide us with detailed accounting of SASG (51%) liquid and monetary funds and assets in Niisitapi Sovereign Bank SASG; and and (2) request the return and recovery of SASG's NSB KTT Contract and Server(s) with detailed accounting of all transactions completed world-wide.

April 19, 2024, SASG issued you a world-wide *Notification to Cease and Desist & Temporary Suspension of Usage of SASG Rights and Privileges* (attached). Instead, you have continued to use our Niisitapi Sovereign Bank SASG (NSB) KTT Contract and Server(s) KTT Settlement Agreements and transactions, and to transfer, move, divert, divest, invest, and monetize, our liquid and monetary funds and assets, including gold, from NSB to other financial banking institutions, world-wide, to your advantage, and to the disadvantage of the true Sovereign Blackfoot People, our humanitarian projects, and to our economic security.

### **HISTORY OF SASG & NIISITAPI SOVEREIGN BANK SASG (NSB)**

Sovereign© Aapaitsitapii© Siksikaitsitapiskahkoo© Government© (SASG) is comprised of Blackfoot Indians representing the True Blackfoot People in Blackfoot Territory, North America. SASG is not affiliated with Blood Band, aka Blood Tribe, the Indian Act band created in 1936 by *The Federal Act*, a federal statute in Canada. Blood Band/Blood Tribe is not a Sovereign Blackfoot entity.

In 2021, SASG established Niisitapi Sovereign Bank SASG (NSB) as a sovereign humanitarian bank to establish economic security and to fund humanitarian projects for our Blackfoot People.

SASG, as owner of Niisitapi Sovereign Bank, established a partnership with Smart Portfolio Group (SPG), as 49% stake holder. SASG did not relinquish, or sell, our Sovereign Blackfoot Rights to SPG, and its derivatives, also known as Smart Portfolio Proprietary Limited and Smart Portfolio Group Proprietary Limited (SPGPL), of Australia and New Zealand. SPG published establishment of Niisitapi Sovereign Bank SASG (NSB) and used Blackfoot Intellectual Cultural Property.

In 2021, SASG named NSB Board of Directors as: Byron Bruised Head and Eugene Carlos Fox; Chris Shade, a Blackfoot Advisor/Elder, and former Chief of Blood Band/Blood Tribe; and Art Sao, also known as Ohn Art Sao, and Harold Kereama, also known as Harold Vincent Tutamua Kereama, both non-Blackfoot, non-Sovereign, SPG representatives based in Australia and New Zealand.

After NSB Board of Directors were named, Chris Shade informed Mr. Bruised Head and Mr. Fox that Mr. Kereama was prohibited from managing companies in New Zealand, who learned from New Zealand "Notice Prohibiting Person From Managing Companies" that Peter Barker, Deputy Registrar of Companies, prohibited Harold Vincent Tutamua Kereama from being a director or promoter of, or being concerned in, or taking part, whether directly or indirectly, in the management of any company for a period of four years and six months as of March 27, 2008. To date, NSB Chairman of Board Chris Shade, and NSB Board of Directors Art Sao and Harold Kereama, have never provided any money to SASG for Blackfoot People. Instead, Mr. Shade, Mr. Sao and Mr. Kereama, and their counterparts, took control of NSB, managed it from their world-wide locations, based in Australia, New Zealand, China, Switzerland, Ireland, England, Suriname, Estonia, Morocco, Oman, United States of America (USA), from where they engaged in world-wide KTT Settlement Agreements and transactions to transfer, move, divert, divest, invest, and monetize, our liquid assets, monetary assets, from Niisitapi Sovereign Bank SASG and the Blackfoot People to other financial banking institutions, world-wide.

In 2024, Mr. Shade informed Mr. Bruised Head and Mr. Fox that he was appointed as NSB Chairman of Board by Mr. Sao and Mr. Kereama. Mr. Shade's appointment was done without consultation or knowledge of Mr. Bruised Head and Mr. Fox. In April 2024, Mr. Shade misaligned himself from SASG to SPG, therefore, he was removed from NSB Board by Mr. Bruised Head and Eugene Carlos Fox of SASG. Mr. Shade no longer represents SASG or Niisitapi Sovereign Bank SASG.

Mr. Shade, Mr. Sao, Mr. Kereama, and their counterparts, have engaged in deceptive and fraudulent banking practices.

- They have not been fiscally responsible, compliant, accountable, transparent, in accordance with SASG and International Banking Regulations
- When we questioned them about our assets, they refused to provide us with any documentation about our Niisitapi Sovereign Bank SASG KTT Contract/ Server(s) developed in 2021, banking financial transactions, quarterly and yearly financial reports, bank ledgers, etc. (KTT: Key Telex Test).
- Instead, they engaged in identity theft and impersonation of our historic Sovereign Blackfoot names and addresses. We suspect they have engaged in bank fraud, securities fraud, shareholder fraud, wire fraud, mail fraud, and internet fraud, all considered criminal acts under Criminal Code of Canada (CCC).
- In 2024, NSB Director Chris Shade In 2024, Mr. Shade informed Mr. Bruised Head and Mr. Fox that he was appointed as NSB Chairman of Board by Mr. Sao and Mr. Kereama.
- Mr. Shade's appointment was done without consultation or knowledge of Mr. Bruised Head and Mr. Fox. He misaligned himself from SASG to SPG, therefore, SASG NSB Directors Byron Bruised Head and Eugene Carlos Fox removed Mr. Shade from NSB Board in April 2024. Mr. Shade no longer represents SASG or Niisitapi Sovereign Bank SASG.

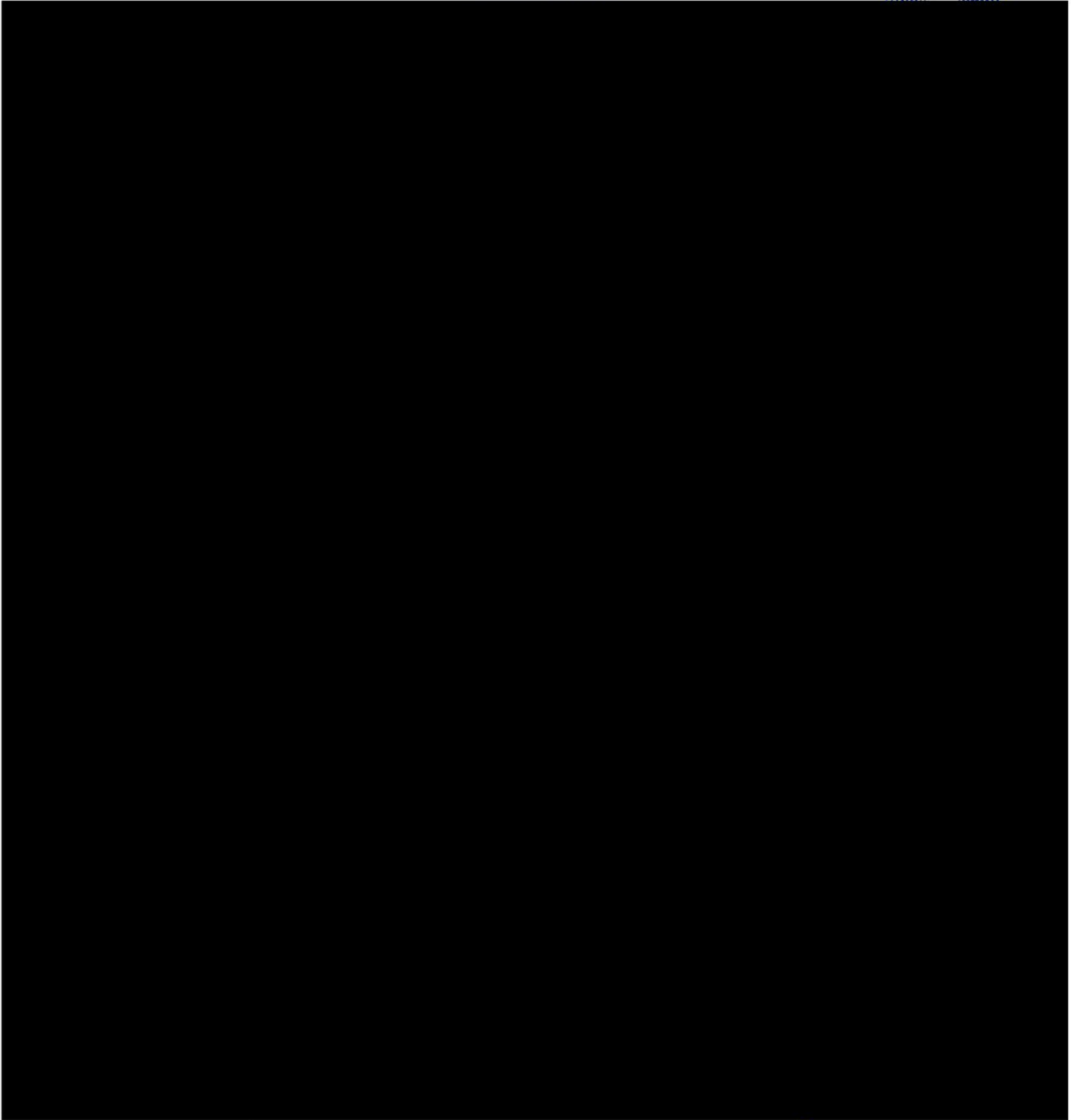

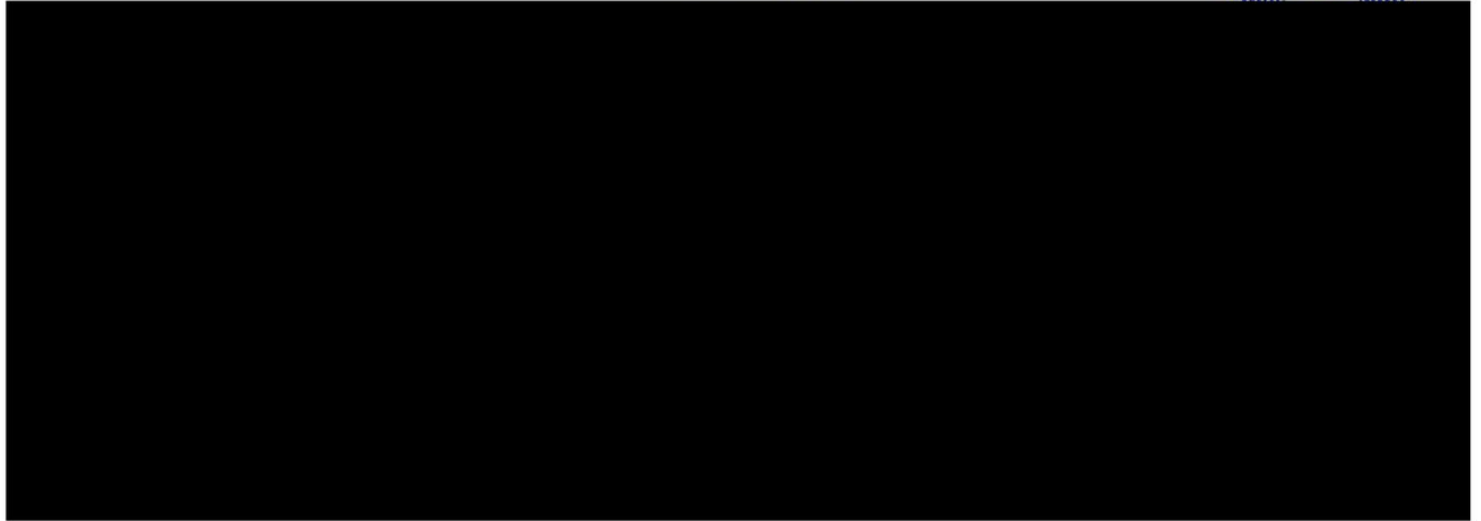

**August 4, 2024:** It was brought to SASG attention, Art Sao of SPG, as Niisitapi Sovereign Bank SASG Director, New Zealand; Theodore T. Ross of SP Monza Bank & Monza Capital LLC, of USA and New Zealand, and KVK Investments Limited of Texas and England; and Mr. Chris Shade of Niisitapi™ Aapaitsitapii™ Siksikaitsitapiskahkoo™ Government™; together, made unlawful illegal changes to our Niisitapi Sovereign Bank SASG, our Sovereign Blackfoot Government name, and our historic addresses, “for the purpose of “clarifying certain operational elements in reference to Niisitapi Sovereign Bank (“NSB”) transactions. Without our knowledge and consensus they changed:

- a) Our bank letterhead name from Niisitapi Sovereign Bank SASG to Niisitapi Sovereign Bank. They deleted the SASG from our name;
- a) Our formal government name from Sovereign© Aapaitsitapii© Siksikaitsitapiskahkoo© Government© to Niisitapi™ Aapaitsitapii™ Siksikaitsitapiskahkoo™ Government™;
- b) Our address from Niisitapi Sovereign Bank of SASG (NSB), Elder Center Building 4, Stand-Off, Treaty 7 Territory, T0L 1Y0, Sovereign© Aapaitsitapii© Siksikaitsitapiskahkoo© Government© (SASG), to Moccasin Flats Plaza, Unit 5, Standoff, Alberta, T0L 1Y0, NIISITAPI (CANADA), a vacant office space.

SASG questions why all of you are operating fraudulently under the guise of our Sovereign Blackfoot Identify, historic address, and cultural intellectual property, and using our Sovereign Banking KTT (Key Tested Telex) Contract and Server(s), to transfer, move, divert, divest, invest, and monetize, our liquid and monetary funds and assets, includes gold, possibly, to other financial banking institutions, world-wide?
