SASG no longer authorizes you to represent SASG in any form of banking, financial, business, or with any and all other matters, with Niisitapi Sovereign Bank SASG, Central Bank of Niisitapi, Niisitapi Development Bank . . . or with any and all of their derivatives, world-wide."**

November 1, 2024: Excerpt:

"Due to deceptive and fraudulent banking practices, this letter serves SASG Request for formal recognition of our Sovereign Blackfoot Rights and Privileges associated with SASG, Niisitapi Sovereign Bank SASG, Central Bank of Niisitapi, Niisitapi Development Bank, and/all derivatives, including Niisitapi Sovereign Bank," newly formed by Chris Shade, SPG's Art Sao, Julian T. Ross. **SASG does not authorize any of you: (1) To use our Sovereign Blackfoot names, includes Sovereign Aapaisitapii Siksikaitsitapiskahkoo Government, Niisitapi Sovereign Bank SASG, Central Bank of Niisitapi, Niisitapi Development Bank, and any and all derivatives, thereof, or affiliated, and misrepresent yourselves under the guise, exploitation, and proliferation, of our Sovereign Blackfoot identity, in any financial, business, matters, SASG does not authorize any of you: (2) To use our Sovereign NSB KTT Contract/Server(s), developed for Niisitapi Sovereign Bank SASG, specifically in 2021, by Mr. Eleazor Diaz and Hipercapital Financial Offshore Bank Panama SA."**

In closing, we have evidence that our Sovereign Blackfoot assets have been divested, diverted, invested, by SPG and SPG associates/affiliates, world-wide and on Internet. This includes theft and misappropriation of our Blackfoot Sovereignty, Identity, Historic Addresses, Cultural & Intellectual Property. These activities will be reported to appropriate banking institutions, world-wide, including Bank of International Settlements (BIS), European Central Bank (ECB), Federal Reserve System (FRS), Australian Securities and Investments Commission, Securities Commission New Zealand, International Monetary Fund (IMF), United Nations, etc.; and to international law enforcement agencies, for investigation, and, prosecution, possibly,
